

Privacy policy

1. General information

The following information provides a simple overview of what happens to your personal data when you contact us or order a service. Personal data is any data by which you can be personally identified. For detailed information on data protection, please refer to this document.

How do we record your data?

Your data is collected when you give it to us, when you give us your business card or when you conclude a contract with us.

What are the purposes we use your data for?

Your name, address data and e-mail address, as well as other collected data, may be stored by us for the purpose of contacting you, processing contracts and providing product information to clarify your concerns, transferred to Berghof GmbH and other Berghof subsidiaries and also used there for contacting you and providing product information. We do not transfer the data to other third parties unless we are obliged to do so by law.

You can object to this use of data in writing at any time. The contact options for this can be found further down in the form.

What rights do you have as far as your information is concerned?

You have the right to receive information about the origin, recipient and purpose of your stored personal data free of charge at any time. You also have the right to demand the correction, blocking or deletion of this data. You can contact us at any time at the address below if you have any further questions on the subject of data protection. Furthermore, you have the right to lodge a complaint with the competent supervisory authority.

2. General information and mandatory information

Data protection

We take the protection of your personal data very seriously. We treat your personal data confidentially and in accordance with the statutory data protection regulations and this data protection declaration.

Withdrawal of your consent to data processing

Many data processing operations are only possible with your express consent. You can revoke consent you have already given at any time. For this purpose, an informal communication by e-mail to us is sufficient. The legality of the data processing carried out until the revocation remains unaffected by the revocation.

Right of appeal to the competent supervisory authority

In the event of violations of data protection law, the data subject has a right of appeal to the competent supervisory authority. The competent supervisory authority for data protection issues is the State Commissioner for Data Protection and Freedom of Information of Baden-Württemberg.

Right to data portability

You have the right to have data that we process automatically on the basis of your consent or in fulfilment of a contract handed over to you or to a third party in a common, machine-readable format. Information, blocking, deletion

Within the framework of the applicable legal provisions, you have the right at any time to free information about your stored personal data, its origin, recipients and the purpose of data processing, as well as the right to correct, block or delete this data if necessary. 4. Audio and video conferencing

For communication with our customers, we use, among other things, online conference tools. In this case, your personal data (e-mail address and/or your telephone number) is collected and processed by us and the provider of the respective conference tool. Metadata such as duration, start and end as well as technical data such as IP addresses, device IDs, device type, operating system type and version, etc. are collected.

The conference tools are used to communicate with prospective or existing contractual partners or to offer certain services to our customers (Art. 6 para. 1 lit. b GDPR). Furthermore, the use of the tools serves the general simplification and acceleration of communication with us or our company (Art. 6 para. 1 lit. f GDPR). If consent has been requested, the tools in question are used on the basis of this consent. Consent can be revoked at any time with effect for the future.

5. Further information

Storage duration

Unless a more specific storage period has been specified in this privacy policy, your personal data will remain with us until the purpose for which it was collected no longer applies. If you assert a justified request for deletion or revoke your consent to data processing, your data will be deleted, unless we have other legally permissible reasons for storing your personal data.

Basis for processing

The basis for data processing is Art. 6(1)(a) GDPR, the data subject has given consent to the processing of personal data relating to him or her for one or more specific purposes; and Art. 6(1)(b) GDPR, the processing is necessary for the performance of a contract to which the data subject is a party or for the implementation of pre-contractual measures taken at the data subject's request.
